

Post Acceptance Author Journey: Manipal Academy of Higher Education institution associated corresponding authors

- 1. How do we determine eligibility of the article for the MAHE agreement?
- The acceptance date of the article should be on or after the start date of the agreement
- The corresponding author must be affiliated with a participating institution in the agreement
- The article must be from a participating journal



2. Specifics of the agreement

- All Institutions of Manipal Academy of Higher Education are eligible for the agreement
- Core Hybrid journals are included



3. What is the definition of the corresponding author for the purpose of the agreement?

- Corresponding author is the author who submits the article to Elsevier and stays in contact with Elsevier in the end-to-end journey
- This is the author who makes the publishing choice on behalf of the author group
- Every article has one corresponding author



4. Role of the institutional Librarian/Admin in the Elsevier OA Platform (EOAP)

- By the time the article is in your EOAP, we have published the first version of the article in ScienceDirect (within 48 hours of acceptance)
- You therefore do not approve the publication of the article; you validate whether the corresponding author can make use of the APC funding under the agreement
- As an agreement administrator, you have full rights to decide whether the author is eligible for the agreement
